INTRODUCTION

This form is to be used by the owner(s) to register a dog for a **Non-Resident Activity Registration Number** from the Kennel Club of Jersey. It is not to be used for a dog eligible for entry in the Pedigree Register of the Kennel Club of Jersey.

NOTES FOR GUIDANCE

1. The breeder(s) is/are the owner(s) of the dam at the date of whelping.
2. Unless either the breeder's declaration is signed by the breeder or the application is accompanied by a pedigree signed by the breeder, the parentage should be shown as "unknown".
3. The declaration must be signed by all the parties having ownership of the dog
4. Apart from a dog eligible for entry in the Pedigree Register, any dog, of any ancestry, may apply for a Non-Resident Activity Registration Number from the Kennel Club of Jersey.
5. A dog with a Non-Resident Activity Registration Number from the Kennel Club of Jersey shall not be entered for any competition under Kennel Club of Jersey Rules and Regulations except Agility, Obedience Classes, Field Trials, Working Trials and Heel Work to Music. (Please note – once registered with an Activity Registration Number the dog **can not** be transferred to the Pedigree Register)
6. When at the date of closings of entries for competition an exhibitor has applied for, but not received a Non-Resident Activity Registration Number, the dog may be entered in the name shown as first choice on this form, followed by the letters N.A.F (name applied for)

GUIDELINES FOR NAMING DOGS

7. When requesting a name on this form please bear in mind the following
 - (a) A name must consist of more than one word but not more than 24 letters including affix (if any). Note an affix is a word which, upon application, is granted by the Kennel Club of Jersey and is reserved for the sole use of the affix holder(s) in the naming of dogs. It is not necessary to have an affix in order to register a dog.

- (b) An identical name already used cannot be used again unless fifteen years have elapsed since the name was previously allowed. It can be used as part of the name in conjunction with an affix or another word making it unique
 - (c) A name which conflicts with an approved and current affix to another person will not be accepted. Any affix granted by the Kennel Club of Jersey and/or the Guernsey Kennel Club will also be protected by the Kennel Club of Jersey.
 - (d) The surname of the applicant is not acceptable.
 - (e) The name should not begin with a single lettered word.
 - (f) Initials cannot be used and abbreviations may be disallowed.
 - (g) Numbers in figures are not acceptable. Numbers in words are acceptable except when used to indicate a sequence e.g. "Jersey Bean the Second".
 - (h) Punctuation marks may be disallowed.
 - (i) Canine terms are not permissible e.g. "Dog", "Bitch", "Kennel", "Champion", "Crufts", names of breeds.
 - (j) If an affix is to be used when registering a dog the affix must appear as the first word in the name. Please note that at a later date a new owner of a dog may add his own affix, if he has one, at the end of the dog's name, unless a request to endorse the registration "name unchangeable" is made (additional fee due).
 - (k) It should be noted that once a name has been registered it may only be changed by the addition of the owners affix to the original name. It is not possible to change the name in any other way.
 - (l) The Kennel Club of Jersey will not accept a name which is similar to an existing name and/or which may create confusion.
 - (m) The Kennel Club of Jersey reserves the right to refuse any name which it considers inappropriate or offensive.
8. To avoid rejection of an unacceptable name (mainly through accidental use of an approved affix) applicants must give alternative name choices otherwise the Kennel Club of Jersey may select a name without further

reference to the owner.

9. Should none of the alternative names be available the Kennel Club of Jersey may select a name. It should be noted, however, that if the Kennel Club of Jersey selects a name for registration, that name cannot afterwards be changed apart from the addition of an affix.

FEES

10. All applications must be accompanied by the correct fee. Payment should be made by cheque, payable to the Kennel Club of Jersey and crossed "A/C Payee". Stamps are not acceptable.

NON ACCEPTANCE OF REGISTRATION ETC

11. The Committee of the Kennel Club of Jersey reserves the right to reject any application to register an affix or to register or transfer any dog or to change or cancel a name and may cancel or suspend any registration or transfer or grant of an affix already made.
12. The acceptance of a registration is not a guarantee of its accuracy.
13. This form remains the property of the Kennel Club of Jersey.
14. When you have completed the form, please send it together with the fee to the Registrar of the Kennel Club of Jersey.
